



Step 1: Assembly of the Main Bracket

Note the u-bracket spacer has a small shoulder on one end. This goes into one of the three mounting position holes on the main bracket, depending on your needs. Any position will fit most firearms, but the outermost hole provides the most universal mount. Insert the u-bracket spacer through the rubber retainer strap as shown in Figure 2. Next, insert the M6 countersink machine screw through the u-bracket and through the spacer, then onto the main bracket. Use the flat washer and nylon insert locknut to secure this connection. The u-bracket will rotate to best cradle your buttstock or forearm stock.

Step 2: Attach the Bracket to your ROPS Bar

The ROPS bar will be sandwiched between the main bracket and backing plate as shown in Figure 2, Detail A. Place the 2 attachment bolts as close to the ROPS bar edge as possible for maximum grip. The vertical separation will determine the length between u-brackets and the upward angle of the firearm for safety in transport.

The photo shows a typical mounting arrangement. The rubber retainer straps have multiple grip holes for the security of your firearm.
